## 3. GLOBAL LAW PROGRAM (courses taught in English)

The **DIREITO SP Global Law Program** was designed for international and FGV students. This program aims to introduce foreign students to the Brazilian Legal System and to promote a broad debate on issues of global relevance in a Brazilian perspective. The Global Law Program is divided in two terms with a total of four disciplines. Exchange students are supposed to attend three of these disciplines<sup>1</sup>. Moreover, one of these disciplines is **mandatory** for foreign students: **Introduction to the Brazilian Legal System**. Each term will last two months.

In addition to these disciplines **DIREITO SP** will offer a series of short-term courses on contemporary issues taught in English. These short-term courses will be conducted by both foreign and **DIREITO SP** professors.
